FMCSA – Federal Motor Carrier Safety Administration Special Investigations Unit

The FMCSA was established within the Department of Transportation on January 1, 2000. Formerly a part of the Federal Highway Administration, the Federal Motor Carrier Safety Administration's primary mission is to prevent commercial motor vehicle-related fatalities and injuries. Activities of the Administration contribute to ensuring safety in motor carrier operations through strong enforcement of safety regulations; targeting high-risk carriers and commercial motor vehicle drivers; improving safety information systems and commercial motor vehicle technologies; strengthening commercial motor vehicle equipment and operating standards; and increasing safety awareness.

 detecting and apprehending transporters and/or users of illicit drugs involving a commercial motor vehicle
 (CMV). The program focuses on the development and distribution of criminal interdiction techniques to rapidly
 identify in-transit CMVs and drivers engaged in criminal activity.

HIDTA – High Intensity Drug Trafficking Areas Program

Created by Congress in 1988, the High Intensity Drug Trafficking Areas (HIDTA) Program coordinates and assists federal, state, local, and Tribal law agencies to address regional drug threats with the purpose of reducing drug trafficking and drug production in the United States. The HIDTA Program oversees 33 regional HIDTAs in all 50 states, Puerto Rico, the U.S. Virgin Islands, and the District of Columbia. Nationwide, the program comprises more than 900 investigative, interdiction, and intelligence-sharing initiatives. Regional HIDTAs also collaborate closely with public health partners on innovative strategies to reduce fatal and non-fatal overdoses and substance use.

ODMAP – Overdose Detection Mapping Application Program

ODMAP provides near real-time suspected overdose data across jurisdictions to support public safety and public health efforts to mobilize an immediate response to a sudden increase, or spike, in overdose events. ODMAP was developed and is managed by the Washington/Baltimore HIDTA.
