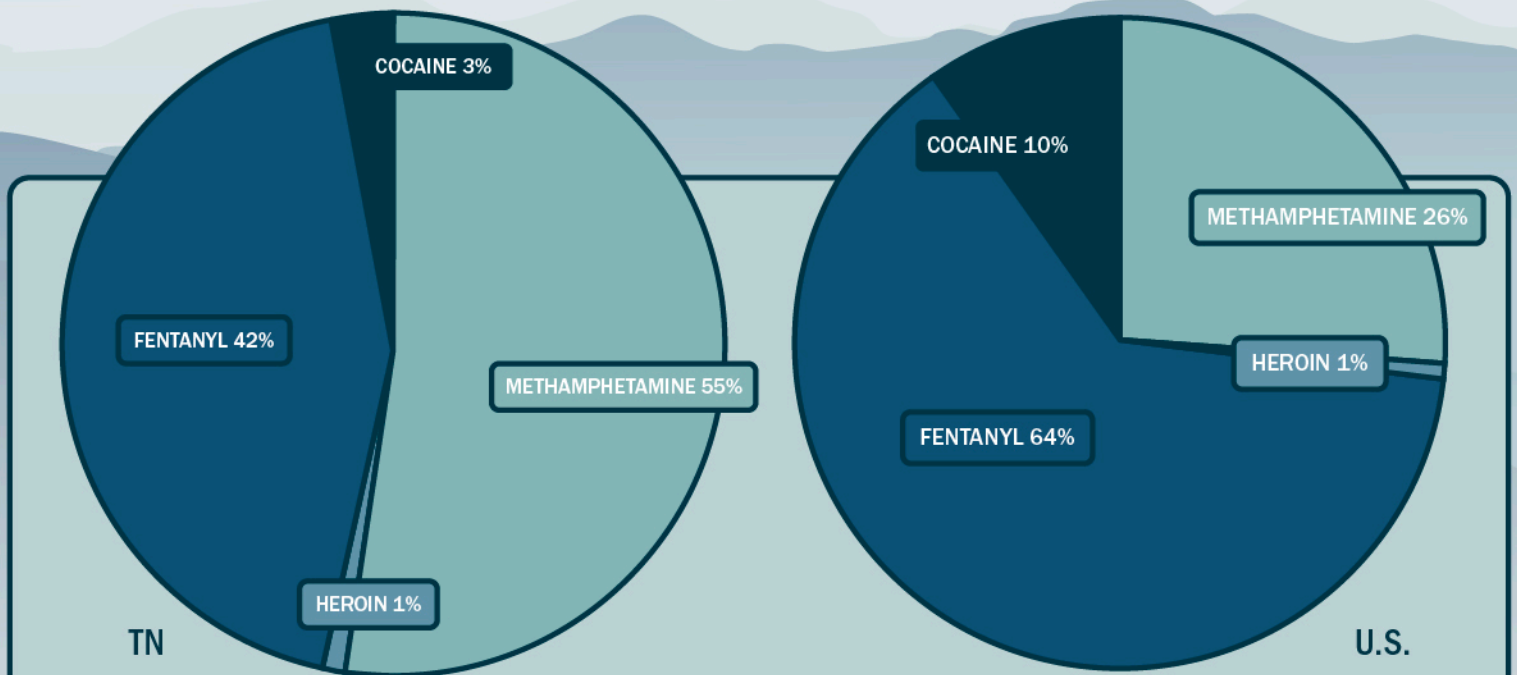

### TENNESSEE VS UNITED STATES

#### Q4 2024 DRUG SEIZURES IN POTENTIAL LETHAL DOSES

Methamphetamine made up over half of Tennessee's potential lethal drug doses—more than twice the national rate—while fentanyl led nationally, revealing a striking difference in drug threats.

## 2024 4TH QUARTER KEY FINDINGS

**85%** POTENTIAL LETHAL  
DOSES SEIZED

Just four counties—Shelby, Davidson, Hamilton, and Knox—accounted for over 85% of Tennessee's potential lethal drug doses in late 2024.



**730,529**

potential lethal doses of **FENTANYL** in Davidson County, followed by **555,936** in Hamilton, **468,779** in Knox, and **198,771** in Shelby County.



**2.38 MILLION**

potential lethal doses of **METHAMPHETAMINE** in Shelby County and **163,202** in Coffee County.



**106,009**

potential lethal doses of **COCAINE** in Shelby County and **18,563** in Davidson County.



**53,616**

potential lethal doses of **HEROIN** in Shelby County and **2,948** in Greene County.

Note. Elevated totals in Shelby County are disproportionately affected by the presence of a national transportation hub in Memphis, which serves as a central distribution point for domestic and international parcel shipments.

Note. Potential lethal dose conversion estimates are based on a Drug Threat Analysis Group (DTAG) model using the formula: (Mass in kg × 1,000,000 × Purity Fraction) ÷ Lethal Dose (mg). Assumptions include: cocaine - 85% purity, 1,200 mg LD; methamphetamine - 94.7% purity, 200 mg LD; heroin - 70% purity, 75 mg LD; fentanyl - 19.2% purity, 2 mg LD. These figures reflect ongoing internal research and are subject to refinement. Source: DTAG, unpublished data, 2025.
